Thank you for considering SOUTHERN AUTO TRANSPORT SERVICES, INC. for the shipment of your vehicle. Our main objective is the **SAFE & SATISFACTORY DELIVERY** of your car at an affordable price. We specialize in the transport of vehicles throughout the United States and Canada.

Your car will be transported on regular car carriers. Simply fill out your **SHIPPING ORDER** and send it to us ASAP so we can make the necessary arrangements. We prefer to receive the Shipping Order **3-4 WEEKS** before the vehicle pickup date to help us better serve you. A delayed Shipping Order will not make a difference in the service, however, it may delay the pickup date of your car. When filling out "first date car available line", be sure to list the first date your car is available for us to pickup. Also if you are flying out, or otherwise leaving the pickup address, be sure to specify that "car must be picked up by your departure date." Once the arrangements have been made and the pickup time approaches we will contact you with an agreed upon time for pickup. The driver will phone you the day before his arrival to get directions and arrange the pickup of your vehicle. Once the vehicle is picked up we normally allow 7-10 DAYS for delivery. Your car will probably be delivered in less time however, delivery dates are not guaranteed. The process for delivery is the same as pickup, you will be called prior to delivery for directions and time of delivery.

IMPORTANT NOTE: Please allow no more than 1/4 tank of fuel in the vehicle to avoid exceeding weight limitations.

WE ARE NOT RESPONSIBLE FOR ARTICLES PACKED INSIDE THE CAR OR TRUNK. IF YOU MUST PACK THINGS IN THE CAR, PLEASE KEEP WEIGHT TO A MINIMUM.

WE CANNOT ACCEPT ANY OVERLOADED VEHICLES THAT ARE DIFFICULT TO LOAD OR UNLOAD ONTO THE CAR CARRIER.

CUSTOMER/CARRIER CONTRACT TERMS AND CONDITIONS

Carrier will not be liable for:

1. Damage caused by leaking fluids, cooling system antifreeze solution, battery-acid, or industrial fallout.
2. Radio antennas that do not retract to no more than (3) inches above the hood or fender of the vehicle being transported.
3. Loss or damage to tape playing, recording, radio, or other sound reproducing or transmitting-receiving equipment which is not factory installed as part of the vehicle being transported.
4. Mechanical functions, exhaust assembly, alignment, suspension, or tuning of vehicle being transported.
5. Carrier shall have the full benefit of any insurance that has been effected on the vehicle or said property unless said insurance coverage is void while the vehicle or property is in possession of the carrier.
6. Delivery of any particular schedule. Contract of carriage is governed by terms and conditions of the Uniform Straight Bill of Lading.
7. Loss or damage to articles left in vehicle.
8. Damages caused by freezing of cooling system and/or batteries. Protection from freezing will be furnished by and at the expense of the owner.
9. Auto rentals due to late delivery.
10. Damage to any car that cannot be driven on or off transporter under its own power, or with no brakes or parking gear. Service charge to jump start or tow on or off transporter.
11. Damage to glass and T-tops due to body flexing.
12. Damage to tires (cuts, puncturing, scrapes, etc.).
13. Any damage resulting from failure of factory tie down brackets or pull through of frame tie holes.

TERMS AND CONTRACT

1. Shipper is responsible for preparing vehicle for shipment. All loose parts, fragile or protruding accessories, low hanging spoilers, antennas, luggage racks, etc., must be removed and/or properly secured. Any part of the vehicle that falls off in transit is shipper's responsibility, including damages to any and all vehicles involved caused by said part.
2. At the time shipper delivers car to carrier for shipment, shipper must furnish carrier with the key to the ignition and trunk and doors. If shipper has an alarm system, it must be turned off, except those systems activated by the door lock.
3. The liability of carrier and its agent for loss or damage to the vehicle or contents under either limited or any extend coverage purchased by the shipper shall be excess to any insurance the owner or shipper has in effect covering the vehicle.
4. Shipper warrants that he will pay all charges due SOUTHERN AUTO TRANSPORT SERVICES, INC. and constitutes the entire agreement between customer and SOUTHERN AUTO TRANSPORT SERVICES, INC.
5. This contract supersedes all prior written or oral representation of SOUTHERN AUTO TRANSPORT SERVICES, INC. and constitutes the entire agreement between customer and SOUTHERN AUTO TRANSPORT SERVICES, INC.
6. By owner's signature or shipper's agent's signature, SOUTHERN AUTO TRANSPORT SERVICES, INC., is hereby authorized to transport the vehicle from the point of pickup specified on the reverse side to the point of destination specified.
7. This order and any shipment hereunder is subject to all terms and conditions of carriers tariffs to the Uniform Straight Bill of Lading, copies of which are available to shipper at the office of carrier and are included herein by reference and made part hereof.
8. No personal belongings are to be transport in vehicle except as are attached to and a part of the vehicle. Carrier disclaims any responsibility for personal belongings that are not a part of the vehicle.
9. Expectations for damages must be noted on Bill of Lading at time of delivery.
10. All calls regarding damages or claims must be made to SOUTHERN AUTO TRANSPORT SERVICES, INC. Claims are subject to a \$200.00 deductible.
11. All damage claims must be submitted to SOUTHERN AUTO TRANSPORT SERVICES, INC. in writing with (2) two estimates. SOUTHERN AUTO TRANSPORT SERVICES, INC. holds the right to request an estimate from a repair shop of their choice.
12. Shipper also agrees that his insurance has the primary responsibility under his comprehensive coverage.
13. SOUTHERN AUTO TRANSPORT SERVICES, INC. does not guarantee delivery on any particular schedule.
